



TERMS AND CONDITIONS

The required specification are as follows:-

1. The agency has to start the operation within 15 days of signing the agreement.
2. The agency shall provided new small pedal boats (2-seater,4-seater,and 4-seater rescue Boat).it will be the responsibility of the agency to keep the boats in running condition at all times.
3. The bidder must submit Pan card,2 Recent passport size Photograph ,Proof of residence(Copy of Aadhar Card Voter ID ,Driving License,)
4. The Ticket Price for boating is as follows:-
Two seater Boat (Pedal) Rs-40/- (20 Minutes)
Four seater Boat (Pedal) Rs-80/- (20 Minutes)
Four seater Boat (Motor) Rs-200/- (20 Minutes)
- 5.The base price for Boating facility stand Rs-2,00,000/-(Two Lakh) only .
6. Successful bidder have to deposit an SD amounting to Rs-50,000/- (Fifty Thousand).
7. During the tenure of the contract the agency should ensure that it does not pollute pond and that the noise level is maintained within the permissible limit as prescribed by the administration at all times.
8. Days and timings for boating operations will be as fixed by the Bijepur NAC.
9. The agency will be responsible for the overall safety of passengers and must ensure necessary safety arrangements while ferrying the boats including providing life jackets to every visitor. The agency shall also deploy necessary manpower to run/operate the rescue boats . it is the duty of the agency to deploy personnel at the boating section to facilitate visitors for ferrying of boats. The agency shall also deploy a rescue boat and lifeguard to ensure safety.
10. The running and maintenance of the boats will be the sole responsibility of the agency in case of stopping of boating operations by the authority because of high water level in the take or other genuine reasons, no contract fee will be charged from the agency however for other reasons such as breakdown of the boats. shortage of manpower or any operational failure by the contractor ,Bijepur NAC authority will not be responsible and the agency will be required to pay the agreed license fee as per the terms and conditions.
11. The agency will ensure the safety of visitors during the operation of the boats in case of an accident or mishap, the agency will be fully responsible and liable to pay all compensation in this regard the agency may choose to cover this risk through insurance, but Bijepur NAC will not be responsible in any manner.
12. The agency shall at all times keep and maintain the boats and the boating area in Proper state of cleanliness to the satisfaction of the NAC authorities and public.
- 13.The security deposit may be forfeited for any contract violation or breach of agreement
- 14 .The bidder shall operate the assigned boating facility and cannot sublet to other party.
15. The bidder must maintain environmental integrity, prevent landscapes disturbance and keep the pond area weed free. Non-compliance will result in cleaning costs being deducted from security deposit.
16. Unauthorized sign boards are not allowed in the boating area.
17. Employee must wear a uniform with ID card at the bidder expenses.
18. The bidder must print tickets at their own cost.
19. A monthly visitor report must be submitted to the NAC Bijepur.
20. Any legal disputes fall under jurisdictions of Bijepur Court.
21. Only applicants agreeing to all terms & conditions may apply along with a

28. The successful tenderer is required to place one mechanized boat for emergency and rescue incase of capsized boats or any problem in paddle for visitors safety.
